Thank you for your interest in working with PetPrints 3D. The following agreement outlines the terms of our "pawtnership" with your business – named throughout as "the referring partner business."

#### 1. Referral fee

The referral fee paid to the referring partner business shall be calculated as 10% of the net value of goods or services sold by PetPrints 3D as a direct result of the referral from that partner business. Referred customers receive 10% off their orders. Net value shall exclude taxes; packaging, postage, shipping, and insurance fees; refunds; and payments not honoured by a financial institution. Payments to referring partner businesses will be made in Canadian dollars by cheque or e-transfer within 30 days of receipt of payment from the referred customer.

#### 2. Repeat customers

For 90 days following the referred customer's initial order, that customer will be considered a customer referred by the partner business and the partner business will be paid the appropriate referral fee. Any sales of goods or services from PetPrints 3D to that customer after 90 days shall not be subject to a referral fee except where such subsequent purchase is the direct result of a repeat referral from the partner business.

#### 3. Promoting PetPrints 3D

The partner business (recipient of said referral fee) shall, to the best of their representatives' abilities, promote the brand, goods, and services of "PetPrints 3D." This shall be done, at a minimum, by the display of (a) model(s) and PetPrints 3D marketing material in the partner's place of business. The partner shall use other methods of promotion available to the business, such as posts and shares on social media networks, blog posts, client newsletters, etc. The partner business shall not advertise the PetPrints 3D brand, goods, or services as its own. It must be clear that PetPrints 3D is a partner, not a related business.

#### 4. Acceptable referral and order methods

PetPrints 3D will pay the referring partner business the referral fee (10% of net value of goods purchased, etc. – as stated above) when an order is placed through one of these appropriate channels:

- a. The customer purchases goods or services from PetPrints 3D as a result of clicking through a PetPrints 3D banner, badge, or link on the website of the referring partner business. PetPrints 3D will provide a suitable graphic for the partner business's website, if requested.
- b. The customer clearly identifies the referring partner business (AND/OR business owner/representative's name if applicable and known to PetPrints 3D AND/OR uses a unique ordering code assigned to the partner business by PetPrints 3D) on the PetPrints 3D website order form when prompted (e.g., in the field labelled "Where did you hear about us?").
- c. The customer phones, emails, or otherwise contacts PetPrints 3D and clearly identifies the referring partner business (AND/OR business owner/representative's name if applicable and known to PetPrints 3D AND/OR uses a unique ordering code assigned to the partner business by PetPrints 3D). Mention could be either verbally or in writing.

#### 5. Discount for customer

Upon purchase (using an acceptable referral and order method listed in number 4 above), the referred customer will receive a 10% discount off the net value of goods or services sold to them by PetPrints 3D. The discount amount is calculated before taxes; packaging, postage, shipping, and insurance fees; refunds; and payments not honoured by a financial institution.



6. Termination

This agreement between PetPrints 3D and the partner business may be terminated by either party with 30 days written notice to the other party.

7. Failure to comply with the agreement

If the partner business and/or its representative(s) fails to comply with the terms of this agreement, PetPrints 3D will terminate the agreement and the partner business will no longer be eligible to claim commissions generated on past or present customers once referred by the partner business who purchase from PetPrints 3D in the future.
